



Temporary Flight Restrictions (TFR) Website 3.0 Release Notes

Introduction

The Temporary Flight Restrictions (TFR) Website provides a source to review TFR data for flight planning purposes. The site offers a consistent look and feel, enhanced design, and improved functionality implemented from approved TFR requirements.

Comments and enhancements are welcomed from the communities of interest. A list of known issues has been included in this document and will be updated as successive releases are installed.

Browser Requirements

The application framework supports Edge and Google Chrome browsers.

TFR Overview

The TFR Website contains two major pages, TFR List and Graphic Map, which display the scheduling data for TFRs. TFR types as per Title 14 Code of Federal Regulations (CFR) include 91.137 Disaster/Hazard Areas (HAZ), 91.138 Disaster Areas in Hawaii (HID), 91.139 Emergency Air Traffic Rules (EMERG), 91.141 Proximity of the President and Other Parties (VIP), 91.143 Proximity of Space Flight Operations (SPC), 91.145 Vicinity of Aerial Demonstrations and Major Sporting Events (EVT), and 99.7 Special Security Instructions (SEC).

The TFR List page and the Graphic Map page can be filtered by type, center, and state. When the end date/time passes, the NOTAM data will be removed from the site.

The Graphic Map page provides a graphical depiction of TFRs. Additional navigation allows the user to pan in any direction by dragging the cursor within the map.

What's New in This Release

The TFR Website 3.0 release contains modifications and bug fixes that were requested by the Federal Aviation Administration (FAA) as described below:

<u>System</u>

The system enhancements and/or fixes are as follows:

- The TFR Website has been updated to be compatible with the current FAA standard version of the Chrome and Edge Browser.
- The footer information has been modified to be current with the FAA.gov website by removing the Viewers and Readers links and the Transportation.gov link.
- The new version will allow users to check TFRs, pan, zoom in and zoom out on the map instead of looking at static map images. Users will also be able to see clear graphics and can search a location and use measurement tools.

TFR List

The TFR List page enhancements and/or fixes are as follows:

- The TFR List allows the user to filter the list by entering a string.
- The TFR list can be sorted by any column.
- The Text List tab has been modified to allow both sort and filter functionality within the same column simultaneously.

TFR Map

The Graphic Map module enhancements and/or fixes are as follows:

• The Graphic Map has been modified to display TFR shapes dynamically.
